In what format are the records maintained?

On Fri, Feb 21, 2014 at 2:06 PM, ST, RTK-DOS <RA-RTK-DOS@pa.gov> wrote:

The fees contained in 15 P.S. § 153(a) are the statutory fees for corporate and Uniform Code filings made with and retained by the Bureau of Corporations and Charitable Organizations of the Department of State.

The fee statute was drafted well before electronic technology such as .pdf or scanned images existed, where filings were submitted and retained solely in paper form.

Therefore, copy fees are per page, regardless of whether the page is furnished on paper or electronically. Photocopies were generated by the Bureau, which then scanned them into a .pdf at your request.

As to the search fee, any request for copies of the records relating to a specific entity name or number necessarily requires a search of the Bureau's records for those names or numbers. The \$15 fee is intended to capture the Bureau's time and efforts in searching its database for the requested information. Where copies are requested and generated, the results are considered to be the report and therefore a separate report is not generated.

Thank you. Would you mind helping me understand the charges?

It appears that 15 P.S. § 153(a) contains the fee schedule for the Corporation Bureau.

153(a)(10) permits the bureau to charge \$3 for each page of photocopy furnished. 153(a)(10) permits the Bureau to charge \$15 for a "report of record search."

I didn't request a "report of a record search," and I was not furnished with such a report. In addition, you provided electronic copies of the requested records, not "photocopies." So it doesn't seem that the Bureau may charge any of the fees that it has assessed.
